

Location

The land is approximately 1/2 north of Morton on the eastern side of Haconby Lane. Access is via Haconby Lane and right of way along the southern boundary of the former football pitch field.

Description

The land lies in two enclosures and is classified as part Grade 3 and part Grade 2 on the former MAFF Agricultural Land Classification map. It is understood that the majority of the land is underdrained.

Tenure and possession

The land is available to let on a five year Farm Business Tenancy agreement with effect from 1 October 2024 with the rent to be payable half yearly in advance on 1 October and 1 April. The tenancy agreement will be based on a standard one produced by the Lincolnshire Association of Agricultural Valuers.

Early entry may be available subject to the completion of the letting formalities.

Tenantright and dilapidations
